

**Agreement between the Sociedade Brasileira de Física and the Institute of Physics**

To enhance scientific relations and improve communications between physicists in Brazil and physicists in the UK and Ireland, and to extend many of the benefits available to members of each society to those of the other, the Sociedade Brasileira de Física (the "Sociedade") and the Institute of Physics (the "Institute") hereby agree the arrangements which are set out in the Annexes attached to this agreement.

This agreement shall come into immediate effect on signature by both the President of the Sociedade and the President of the Institute, and shall remain in force until either the Institute or the Sociedade gives the other not less than 12 calendar months' written notice of termination. The Sociedade acknowledges that the annual electronic affiliate fee, and the benefits offered to electronic affiliates, may be subject to periodic review by the Institute. The Institute acknowledges that the benefits offered by the Sociedade to Institute members may also be subject to periodic review. Any changes shall be notified to the partner society in writing and shall be posted on the websites of both societies.

## Annex A

### **Joint membership arrangements: members of the Sociedade Brasileira de Física who wish to become electronic affiliate members of the Institute of Physics**

1. The Sociedade will notify all its members of the opportunity to take up electronic affiliate membership of the Institute.

  - Professional help-sheets and other career resources available from the Institute's website or by email;
  - Access to the members' room and facilities at the London headquarters of the Institute, on the same terms as other members of the Institute.
4. The Institute will charge each member of the Sociedade who registers as an electronic affiliate an annual fee currently set at GBP10.

1. The Institute will notify all its members of the opportunity to become affiliate members of the Sociedade.
